

**CAMP PONEMAH 2020**  
**COVID 19**  
**Assumption of Risk & Waiver of Liability**

The novel coronavirus Covid-19 has been declared a worldwide pandemic by the World Health Organization. Covid-19 is extremely dangerous and is believed to spread mainly from person to person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Hampshire Hills Athletic Club and Camp Ponemah have put in place preventative measures to reduce the spread of Covid-19. However, Hampshire Hills/Camp Ponemah cannot guarantee that your child(ren) will not become infected with Covid-19. Further, attending Hampshire Hills/Camp Ponemah could increase your risk and your child(ren)'s risk on contracting Covid-19.

**Waiver and Release of Liability**

By signing this agreement I acknowledge that the contagious nature of Covid-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by Covid-19 by attending Hampshire Hills/Camp Ponemah and that such exposure or infection may result in personal injury, illness, permanent disability and death. I understand that the risk of becoming exposed to or infected by Covid-19 at Hampshire Hills/Camp Ponemah may result from the actions, omissions, or negligence of myself and others including, but not limited to, Hampshire Hills/Camp Ponemah, employees, volunteers, and program participants and their families.

I voluntarily agree and assume all of the foregoing risks and accept sole responsibilities for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability and death), illness, damage, loss, claim, liability, or expense of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Hampshire Hills/Camp Ponemah or participation in Hampshire Hills/Camp Ponemah ("Claims"). On my half and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless Hampshire Hills/Camp Ponemah, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on actions, omissions, or negligence of Hampshire Hills/Camp Ponemah, its employees, agents, and representatives, whether Covid-19 infection occurs before, during, or after participation in any Hampshire Hills/Camp Ponemah program
